This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is publishing the draft report and determination and commencing the second stage of consultation on the Credit Limit Procedures (CLP) V2.

This consultation is being conducted under clause 3.3.8 of the National Electricity Rules (**Rules**), in accordance with the Rules consultation requirements detailed in rule 8.9 of the Rules.

Please identify any information in your submission that you consider is to be confidential, and provide the reasons why you wish that information to be treated as confidential. AEMO reserves the right to publish material that it does not consider to be confidential, but will consult with you before doing so.

Note that material identified as confidential may be given less weight in the decision-making process than material that is published.

### Meetings

In your submission, you may request a meeting with AEMO to discuss the matters under consultation. If you request a meeting, you must state why you consider it necessary or desirable.
