- MPB – Metering Provider category B, accredited to ‘Provide, Install and Maintain’ the metering installation.
- MPA – Metering Provider category A, accredited to ‘Install’ only for type 5 and 6 metering installations.

¹ Accreditation applies to low voltage (LV) metering installations only.

² Accreditation applies to whole current (WC) metering installations only.

³ Distribution Network Service Providers (DNSPs) who no longer ‘Provide, Install and Maintain’ type 1 to 4 contestable metering installations due to Power of Choice changes (from 1 December 2017) but still hold the accreditation.

FAQ (from 1 December 2017):

Q1: Can a Metering Coordinator (MC) or Retailer engage an MPA directly to install meters?

No. As per clause 7.3.2 of the [National Electricity Rules](#) (NER), the MC who is appointed by the Retailer or Large Customer, will appoint an MPB. Once the MC has appointed an MPB for a metering installation, the MPB can engage an MPA to perform the work as a sub-contractor under the MPB’s relevant category of accreditation.

Q2: As an NSW ASP accredited meter installer, do I need to be accredited with AEMO to perform meter installation work only?

No. To perform metering installation work only, it is advised to contact the MPBs on this list to enquire about becoming a sub-contractor for metering work. Please note that the MPB may require you to undergo some form of training to ensure that work is performed in accordance with the MPB’s procedures.
